# Admission requirements

- An elementary school qualification and five years' work experience as a camera assistant; or
- at least a secondary vocational qualification and five years' work experience as a camera assistant and
- a technical assignment containing:
- the candidate's own AV record of an event (news item) saved on a CD or DVD in a digital format in electronic form,
- explanation of the choice of equipment (cameras, lights and sound equipment),
- the rules of safety and health in the candidate's work and
- the candidate's contribution to the visualisation of the project in PDF format, saved on a CD in electronic form.

# **Learning outcomes**

Candidates will be able to:

#### Accessors

Verification and assessment are carried out by committees for the verification and validation of national vocational qualifications, appointed by the National Examination Centre (NEC). ## **Assessment and completion**

**VALIDATION** 

During the counselling process, the candidate prepares a portfolio. The relevant committee assesses the portfolio and validates catalogue content in part or full. If the committee is unable to recognise all catalogue content, it assigns tasks to the candidate for verification.

**VERIFICATION METHOD** 

Technical assignment with oral presentation.

## **Condition for obtaining certificate**

Candidates demonstrate attainment of the knowledge, skills and competences defined in the catalogue of standards of vocational knowledge and skills.

# **Awarding body**

Providers of procedures for identifying and validating national vocational qualifications are entered in a register of providers maintained in the relevant database of the National Reference Point for Occupational Qualifications. Providers include: vocational schools, companies, inter-company training centres, adult education centres, chambers of commerce, etc.
