### **Learning outcomes**

#### Candidates will be able to:

#### **Accessors**

Verification and assessment are carried out by committees for the verification and validation of national vocational qualifications, appointed by the National Examination Centre (NEC). # **Assessment and completion**

#### **VALIDATION**

During the verification procedure, the candidate will prepare a personal portfolio with the help of Armed Forces personnel support. This will be evaluated by a committee and the content recognised in full or in part. In the event that the committee is unable to recognise all catalogue content, it assigns tasks to the

candidate for verification.

**VERIFICATION METHOD** 

Practical verification with an oral presentation.

## **Condition for obtaining certificate**

Candidates demonstrate attainment of the knowledge, skills and competences defined in the catalogue of standards of vocational knowledge and skills.

## **Awarding body**

Providers of procedures for identifying and validating national vocational qualifications are entered in a register of providers maintained in the relevant database of the National Reference Point for Occupational Qualifications. Providers include: vocational schools, companies, inter-company training centres, adult education centres, chambers of commerce, etc.
