## Accessors

## Assessment and completion

### VALIDATION

In the counseling process, the candidate prepares a personal portfolio, which is evaluated by the commission, and if the candidate has provided credible, valid and relevant evidence of knowledge, skills and competencies from the occupational standard, the commission may:

- recognizes the knowledge and skills of the occupational standard in full,
- recognizes the knowledge and skills of the occupational standard in part and determines those knowledge, skills and competences that will be tested,
- does not recognize any knowledge and skills of the occupational standard because the candidate does not demonstrate any knowledge, skills and competences from the occupational standard, and will reasonably check the entire occupational standard.

### VERIFICATION METHOD

- Practical verification with oral defense.

## Condition for obtaining certificate

Candidates demonstrate attainment of the knowledge, skills and competences defined in the catalogue of standards of vocational knowledge and skills.

## Awarding body

Providers of procedures for identifying and validating national vocational qualifications are entered in a register of providers maintained in the relevant database of the National Reference Point for Occupational Qualifications. Providers include: vocational schools, companies, inter-company training centres, adult education centres, chambers of commerce, etc.
